# Foundation Board of Trustees



**Chairman, Foundation Board of Trustees** Ruth Grant Alsbrooks, Beta Psi-Alabama

Ruth is currently serving her first term as Board Chairman of the Delta Gamma Foundation.

Ruth, a native of Richmond, Virginia, earned her B.A. in speech from the University of Alabama.
