

Funding a Sisters Helping Sisters: Need-Based Scholarship

Delta Gamma has one of the strongest and most respected academic assistance programs in the fraternity/sorority community. Sponsoring a Delta Gamma Foundation need-based scholarship can be an individual effort or that of an alumnae group, collegiate chapter, house corporation or an entire region. All need-based scholarship sponsors can be assured that they have made a difference in the life of a Delta Gamma.

One-Time Award

- A need-based scholarship can be sponsored for a minimum of \$2,500. There is no maximum, and multiple scholarships can be sponsored and awarded.
- Need-based scholarship donations cannot be restricted (e.g. chapter, region, major, etc.).

The Foundation also provides the opportunity to sponsor an endowed need-based scholarship. An endowment ensures a financial award will be given in perpetuity to deserving Delta Gamma sisters in need.

Endowed Fund Award Requirements

- Endowment funds for need-based scholarships must remain unrestricted.
- \$62,500 is the minimum amount required to endow one unrestricted annual need-based scholarship award in perpetuity.
- Endowed scholarships can be funded in a lump sum, in multi-year installments or through a planned gift. A minimum of 20% of the total amount is required to start an endowed scholarship fund with payment periods of up to five years for individuals and alumnae groups and three years for collegiate chapters to reach the full endowment level.
- Endowment funds can be named in honor or memory of an individual, collegiate chapter or alumnae group.
- Once a name is chosen and the paperwork is signed, that will be the name of the fund, forever.
- Annual funds must sit for one full fiscal year (July 1 to June 30) to earn interest before the first award is made.
- Award amounts are calculated based upon the Foundation Board of Trustees approved spending policy. The current policy is 4% of the five year earnings average.
