

### Loyally Anchored Lifetime Dues Program Frequently Asked Questions

# What is Loyally Anchored?

Loyally Anchored is Delta Gamma's new lifetime dues program! This option is designed for members who would like to fulfill their alumnae dues obligation to the Fraternity in a one-time payment as opposed to through annual per capita dues.

# What is the difference between Loyally Anchored and annual per capita dues, and how does 50-year membership factor into that?

Until the time members reach 50 years of membership, they are asked to pay annual per capita dues to remain in good standing. This new Loyally Anchored lifetime dues program is simply an alternate way for alumnae who have not yet reached their 50-year membership milestone to pay annual per capita dues, all at once and not subject to annual amount changes, rather than annually if they so choose.

# How does Loyally Anchored coincide with Delta Gamma's recent inclusivity and financial accessibility efforts?

We know not all members have a desire for this type of program, but there are a number of alumnae members who have requested a one-time payment structure for per capita dues. We are proud to be meeting a need for these alumnae members while also maintaining our current dues structure for those who prefer to pay annually.

By receiving support from our alumnae in this new way, the Fraternity is able to further reduce costs for collegiate members and continue to provide meaningful programming and avenues for connection. If more Delta Gamma alumnae paid their dues until reaching 50 years of membership, costs of collegiate membership would be reduced and we could welcome many more women into our Do Good Sisterhood who today are not able to afford the experience. We appreciate alumnae who are able to contribute through a one-time payment, as this allows us to continue to support Fraternity operations and programming to provide our sisters the ability to become confident, supportive leaders into the future.

# How is this different than making a gift to the Delta Gamma Foundation?

By becoming a Loyally Anchored or Loyally Anchored: Faithful & True member, you are fulfilling your financial commitment to the Fraternity through your alumnae dues. Alumnae dues support a variety of programs separate from those supported through Foundation donations. Your Loyally Anchored or Loyally Anchored: Faithful & True payment is not tax deductible. ### Is participation in this program tax deductible?

No, dues paid to the Fraternity are not tax deductible as we are a 501(c)(7) organization.

### Once I enroll, when should I expect to receive my pin and other benefits?

Upon enrolling in the program, a welcome email and digital member benefits will be delivered to your email inbox within one business day. Your membership lapel pin will be mailed to you within four to six weeks after your enrollment.

## What should I do if I don't receive my pin?

### How can I gift a Loyally Anchored membership to another sister?

These can be given to a recent graduate as a graduation gift or as a way to celebrate a very special award winner in your alumnae group. # What are the Delta Gamma merchandise discounts available to Loyally Anchored members?

For our soft launch we are excited to offer discounts on an exclusive Loyally Anchored collection through Hannah's Closet. Loyally Anchored members will receive 20% off items in that collection and Loyally Anchored: Faithful and True members will receive 50% off items in that collection. We are hopeful to incorporate additional merchandise discounts prior to the membership-wide launch in July 2022 and will communicate with program participants if/when additional discounts become available.

# Are there payment plan options available or do we have to pay the full amount all at once?

Members can pay for Loyally Anchored in one installment or in multiple annual or monthly installments for up to three years.
