# Proposed Additions and Removals to the Convention Approved List for Extension

## ADDITIONS

#### **Removals – No NPC Organizations on Campus**

The 17 recommended removals are campuses that do not currently have any NPC organizations on campus. The Extension Team feels that in the case of exploring a potential extension to a campus where no NPC organizations currently exist, the majority vote of the five closest alumnae groups and five closest collegiate chapters, rather than the Convention Approved List, is preferable as being the first organization to establish on a campus is a more significant undertaking that must be carefully evaluated.
