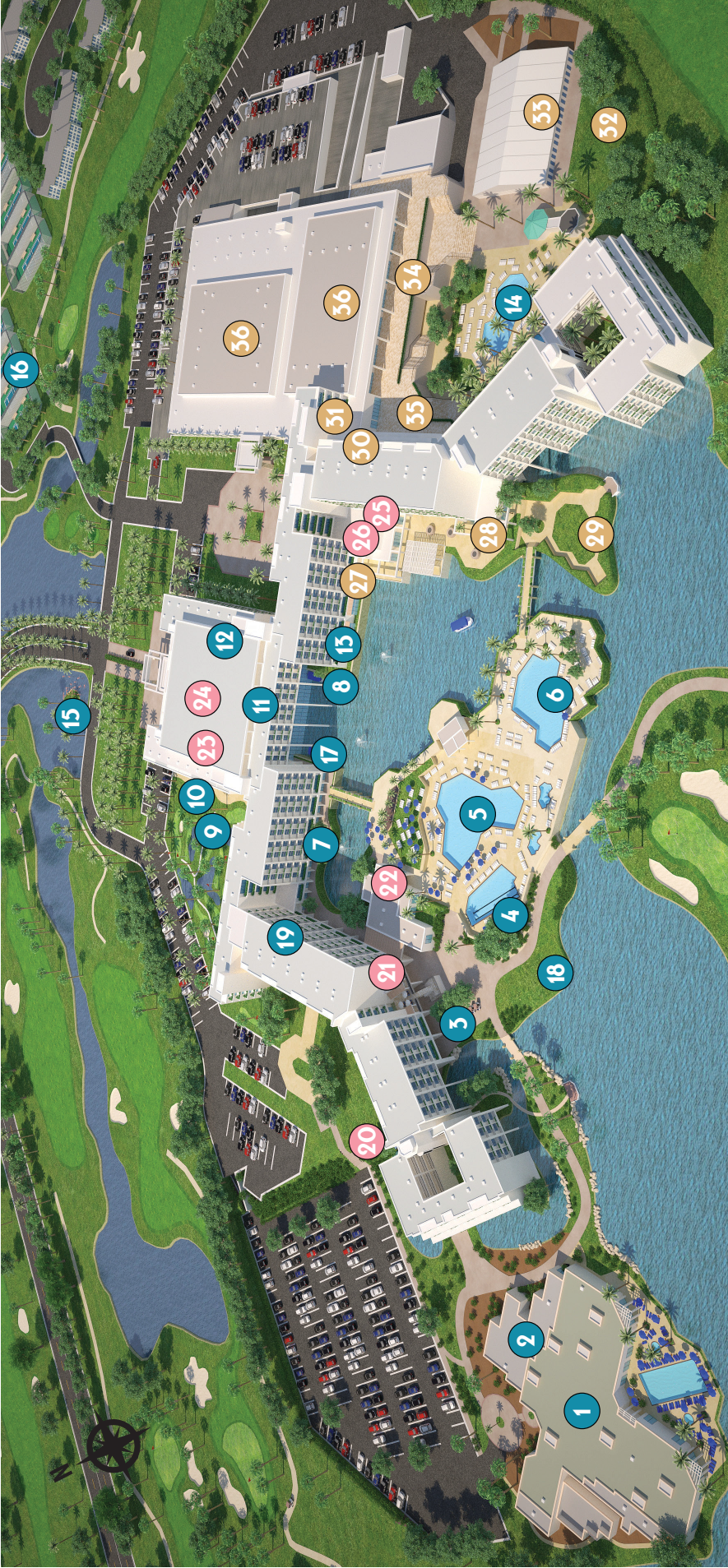

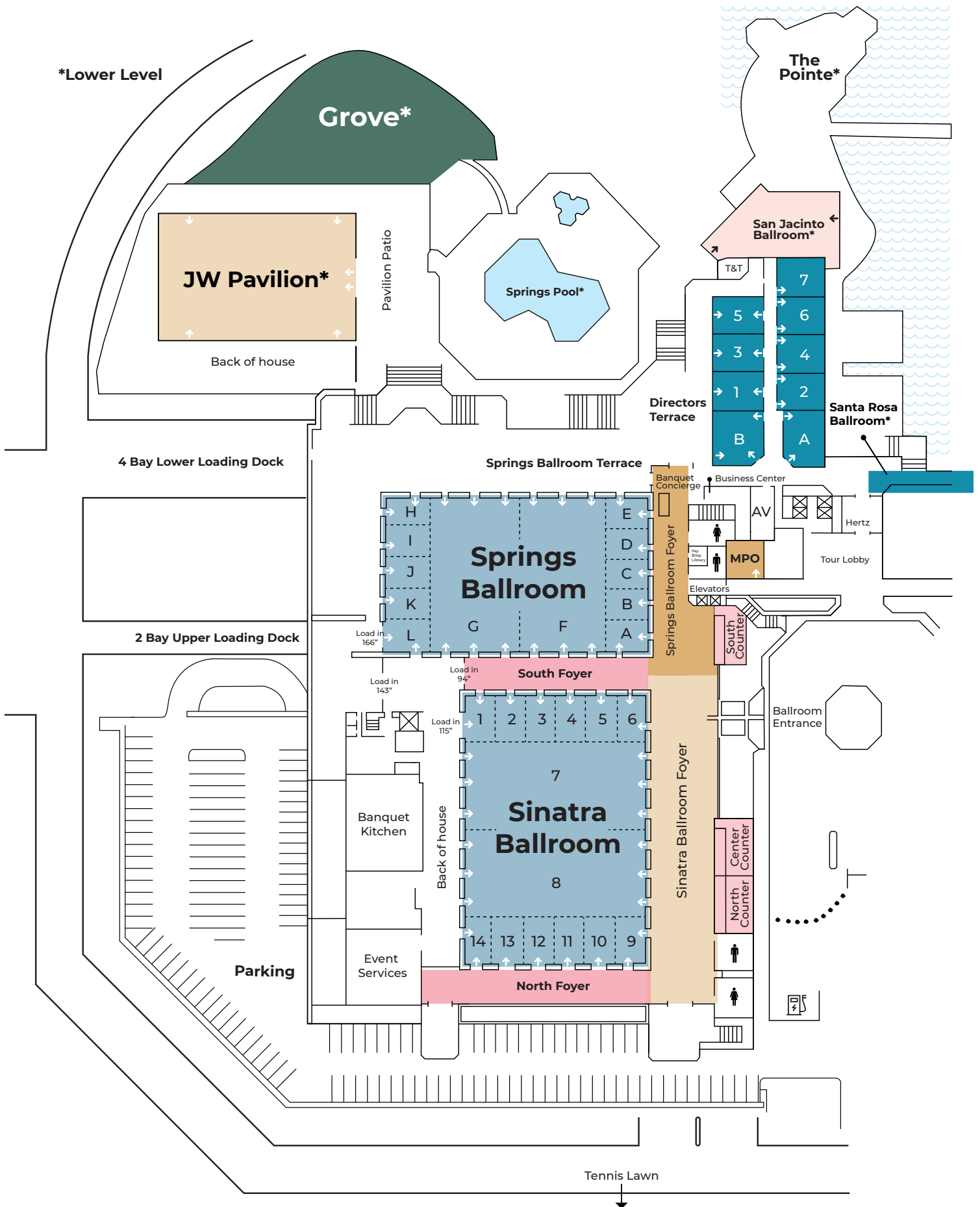

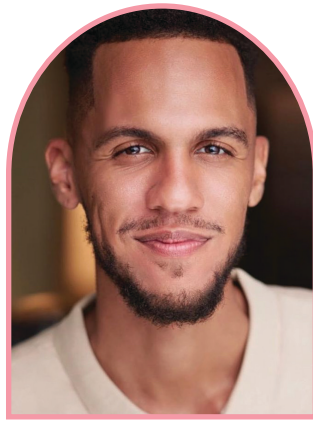

Dani serves as the National Panhellenic Conference Chief Executive Officer and works with the NPC Board of Directors to lead the nation's largest organization advocating the sorority experience and the 26 inter/national women's sororities that comprise the Conference.

Prior to joining NPC, she served as an administrator at each of her alma maters, DePauw University and the Indiana University Maurer School of Law Bloomington. She traveled extensively to visit undergraduate campuses and developed relationships with faculty members, academic advisors and other administrators from coast to coast.

Dani is proud of her 25 years of Delta Gamma volunteer experience. She has served as advisory team chair for various chapters, Regional Collegiate Specialist, Region 4 Director, member of the Fraternity Nominating Committee and of the Structure Task Force (2015-16).



TRACY WALDER, ALPHA NU-USC

Foundation Lectureship Speaker

Former CIA Officer, FBI Special Agent, educator and author of “The Unexpected Spy: My Secret Life Chasing Down Some of the World’s Most Notorious Terrorists”

When Tracy Walder enrolled at the University of Southern California, she never thought that one day she would offer her pink beanbag chair in the Delta Gamma house to a CIA recruiter, or that she’d fly to the Middle East under an alias identity. Graduating with a history degree, she would spend the next four years as a covert operative for CIA’s Counterterrorism Center, assuming aliases, thwarting terrorist attacks and debriefing terrorists at black sites.

After the CIA, she went on to become one of the few women to work on the operations side of both the CIA and FBI, serving as a Special Agent at the FBI’s Los Angeles Field Office and specializing in Chinese counterintelligence operations, specifically the Tai and Chi Mak case, profiled on CNN and in *The New Yorker*. In a single year, Tracy worked on cases involving cybercrime, fraud, and even helped take down one of the most notorious foreign spies ever caught on American soil.

Her book, “The Unexpected Spy: My Secret Life Chasing Down Some of the World’s Most Notorious Terrorists,” candidly details her fascinating real-life story as a young woman in special operations, from hunting terrorists in the CIA to training for the FBI. Following her time at the CIA and FBI, Tracy became a teacher and created a course on national security and foreign policy for young women. Currently, she works as a teacher and adjunct professor of criminal justice and terrorism.

Tracy sits on the board of directors of Girl Security, a nonpartisan, nonprofit organization increasing the representation of women in national security through education. She also sits on the board of Chapman University’s Atallah College of Education and the Highland Park Education Foundation. Tracy earned her degree in history from the University of Southern California and her master’s in education from Chapman University.

Convention Rules

1. All attendees will follow California state law.
2. All attendees are asked to dress professionally for General Sessions, lunches and meetings. Attendees are encouraged to follow clothing guidance as indicated on the Convention website.
3. All sessions are required for delegates unless labeled optional.
4. Non-members and guests may attend workshops, social functions, General Sessions and all meetings for which they are registered, except those containing Fraternity rituals.
5. All persons entering General Sessions, the Election Forum, workshops and meals must be properly registered and identified with a Convention name badge.
6. All sessions will begin on time. Latecomers will be seated at designated intervals.
7. All matters pertaining to resolutions shall be referred to the Resolutions Committee through the Fraternity Constitution and Elections Chair, no later than 12 p.m. PT on Thursday, June 27, 2024. Tina Syring shall be the Fraternity Constitution and Elections Chair.
8. Announcements made from the platform must be submitted in writing to the Fraternity Executive Director before the meeting at which the announcement will be considered. Tracey Doebling Williams is the Fraternity Executive Director.
9. At the conclusion of meetings and meals, promptly exit the room and proceed to the next scheduled event.
10. The parliamentary authority for the Convention shall be that which is listed in the Constitution, Article XXIV: "The parliamentary writings of General Henry M. Robert shall be the authority in all cases not otherwise covered by this Constitution." Susan Eddy Kinney shall be the Fraternity Parliamentarian. Alison Brackins will serve as Parliamentarian for the Foundation Annual Meeting.
11. All personal mobile devices (cell phones, iPad, etc.) shall remain in airplane mode and out of sight during General Sessions.
12. Only granola bars or a similar type of food are permitted provided it is not disruptive to the General Sessions. Beverages must be in a container with a lid.
13. All motions shall be in writing, signed by the mover and sent to the platform via a Convention Page. The mover shall rise and give her name and chapter/Cabinet role for which she is a delegate. It is not necessary for the seconder of the motion to do so.
14. To speak, the delegate and/or the previously designated member shall rise and address the Chair. The delegate who proposes the issue and/or the previously designated member may speak for two (2) minutes on the issue. Any additional delegates wishing to speak on the topic shall have 30 seconds to speak. A delegate may defer their time to another delegate and/or the previously designated member if they are speaking to the same point and need more time to address the issue. Delegates and/or the previously designated member may not speak more than twice to the same question without the permission of the assembly. The "previously designated member" is a member in good standing, a visitor (non-delegate) and approved by the Chair prior to Convention to speak on the proposed Constitutional amendment.
15. With the exception of the previously designated member identified above, it is permissible for visitors (non-delegates) to speak from the floor on questions under consideration, but they may not originate a motion or vote. The visitor may only speak once on the subject.

16. Only voting delegates in good standing may vote on any matter, including votes in General Sessions and Regional Meetings.
17. When voting is conducted by electronic ballot, the delegate will take care in handling the equipment not remove the electronic voting device from the General Session room.
18. Per Delta Gamma Fraternity Election Guidelines, Council candidates and Regional Nominating Committee candidates may not campaign for office, nor may others campaign on their behalf.

Your Role as a Delegate

A voting delegate helps conduct and votes on the official business of the Fraternity. They are required to attend each General Session and Election Forum along with all other programming noted in the Convention schedule. She enjoys all the rights and responsibilities associated with delegate status.

A Convention voting delegate serves in one of the following positions:

- Council
- Fraternity Director
- Constitution and Elections Chair
- Regional Team member
- Collegiate chapter president (or approved alternate)
- Alumnae chapter president (or approved alternate)
- Designated Council-appointed volunteer
- Fraternity Executive Director

One of the most important duties of a delegate is electing the Council:

Council is comprised of the seven women who lead the Fraternity between Conventions. It is important that delegates review the biographies of the candidates, listen to each candidate's speech and responses to questions at the Election Forum, and discern independently the best candidates to lead the Fraternity in the next biennium.

Why I Want To Serve

First, is my longstanding desire to give back to Delta Gamma. As I believe Eta chapter changed the course of my life when they elected me treasurer, I am forever grateful for my career in financial services. Serving as Treasurer is more than giving back; it is also a labor of love.

Finance and housing have many challenges, some from action taken in response to COVID and others due to current economic conditions. I have redefined leadership roles and put together an exceptional team to address these challenges. We will soon launch a two-region pilot to test merging the RFS and RHS positions into a single role (two per region) with each RFHS covering half the chapters for more in-depth engagement and more manageable workloads.

My serving a second term will enable us to fully implement our vision to establish greater long-term financial stability for our chapters and housing.

Fraternity Proposed Constitutional Amendments

PROPOSED COUNCIL-ENDORSED AMENDMENTS

ARTICLE V. SELECTION OF MEMBERS

CURRENT LANGUAGE:

Section 1. Selection of collegiate members

Collegiate candidates may be pledged and initiated by a collegiate chapter, by the procedures followed in the establishment and installation of new chapters, or by the Convention.

A. Eligibility for pledging

To be eligible for pledging a candidate for membership shall meet all of the following qualifications:

1. The qualifications stated in Section 1 of Article IV.
2. Be sponsored by a member of Delta Gamma.
3. Receive the approval of the chapter members in a manner aligned with the Fraternity's approved voting model and in alignment with the objects of the Fraternity as outlined in Article II of this Constitution.
4. Be registered in the college or university where she is to be pledged and have achieved a minimum of a "C" college grade point average. If college grades are not available, an equivalent minimum grade point average of a 2.5 on a 4.0 scale from secondary school may be used.

PROPOSED LANGUAGE:

Section 1. Selection of collegiate members

Collegiate candidates may be pledged and initiated by a collegiate chapter, by the procedures followed in the establishment and installation of new chapters, or by the Convention.

A. Eligibility for pledging

To be eligible for pledging a candidate for membership shall meet all of the following qualifications:

1. The qualifications stated in Section 1 of Article IV.
- ~~2. Be sponsored by a member of Delta Gamma.~~
3. Receive the approval of the chapter members in a manner aligned with the Fraternity's approved voting model and in alignment with the objects of the Fraternity as outlined in Article II of this Constitution.
4. Be registered in the college or university where she is to be pledged and have achieved a minimum of a "C" college grade point average. If college grades are not available, an equivalent minimum grade point average of a 2.5 on a 4.0 scale from secondary school may be used.

RATIONALE:

Use of sponsor forms by both alumnae and collegiate chapters have been on the decline for several years. Removing the sponsorship requirement allows for our collegians to remove a procedural hurdle and make decisions on membership invitations based upon their interactions with potential new members.

ARTICLE V. SELECTION OF MEMBERS

CURRENT LANGUAGE:

Section 2. Selection of alumnae initiates

Non-collegiate candidates may be initiated by a collegiate chapter with Council approval and by procedures determined by Council, provided a candidate for membership shall meet all qualifications set forth by Fraternity policy.

PROPOSED LANGUAGE:

Section 2. Selection of alumnae initiates

Non-collegiate candidates may be initiated by a collegiate chapter with ~~Council~~ approval by **Council or their designees** and by procedures determined by Council, provided a candidate for membership shall meet all qualifications set forth by Fraternity policy.

RATIONALE:

Alumnae initiates are approved by meeting a certain set of criteria, and once they are met, it becomes a transaction that does not require Council oversight. By allowing for alumnae initiates to be accepted by their designees, Council then has the authority to delegate this task to staff or volunteers for more efficient execution.

ARTICLE VI. FEES, DUES AND ASSESSMENTS

CURRENT LANGUAGE:

Section 1. Financial Administration

A. On an annual basis, Council will approve and publish a schedule of dues and fees including any adjustments by May 1. Any annual adjustments of individual dues and fees exceeding 8% of the prior amount shall require a membership vote to become effective. The Fraternity shall collect membership income consistent with this published schedule.

PROPOSED LANGUAGE:

Section 1. Financial Administration

A. On an annual basis, Council will approve and publish a schedule of dues and fees including any adjustments by May 1. Any annual adjustments of individual dues and fees exceeding ~~8~~ **10%** of the prior amount shall require a membership vote to become effective. The Fraternity shall collect membership income consistent with this published schedule.

RATIONALE:

While alumnae dues have seen modest increases, collegiate dues have not been raised in four years, which is a decision that was made by Council in consecutive years to help with affordability. By raising the annual adjustment amount, it allows the Fraternity to make those decisions without fear of falling behind on the costs to operate the Fraternity and not being able to catch back up when economic conditions change. This percentage has not been raised since it was established at the 2006 Convention.

ARTICLE VII. TERMINATION OF MEMBERSHIP

CURRENT LANGUAGE:

Section 1. Authority for resignation

The authority to accept a resignation from membership shall be vested in Council.

PROPOSED LANGUAGE:

Section 1. Authority for resignation

The authority to accept a resignation from membership shall be vested in Council **or their designees.**

RATIONALE:

At the acceptance level, a resignation is a near-automatic transaction that does not require Council oversight. By allowing for resignations to be accepted by their designees, Council then has the authority to delegate this task to staff or volunteers for more efficient execution.

ARTICLE VII. CONVENTION

CURRENT LANGUAGE:

Section 3. Distribution of votes

A ratio for assigning equally weighted vote values for collegiate chapters in relation to alumnae chapters and other official voting members of the Convention shall be determined immediately following the first Credentials Committee Report at each Convention. The ratio will be calculated jointly by the Fraternity President, the Fraternity Constitution Chairman and the Chairman of the Credentials Committee. The Fraternity ratio shall remain in effect for all General Session votes taken for the duration of Convention. Regional ratios shall be calculated jointly by the Fraternity President, the Fraternity Constitution Chairman and the Chairman of the Credentials Committee for Regions as provided in ARTICLE XIX. The regional ratios shall remain in effect for all votes taken during regional meetings for the duration of the Convention.

PROPOSED LANGUAGE:

Section 3. Distribution of votes

A ratio for assigning equally weighted vote values for collegiate chapters in relation to alumnae chapters and other official voting members of the Convention shall be determined immediately following the first Credentials Committee Report at each Convention. The ratio will be calculated jointly by the Fraternity President, the Fraternity Constitution **and Elections** Chairman and the Chairman of the Credentials Committee. The Fraternity ratio shall remain in effect for all General Session votes taken for the duration of Convention. Regional ratios shall be calculated jointly by the Fraternity President, the Fraternity Constitution **and Elections** Chairman and the Chairman of the Credentials Committee for Regions as provided in ARTICLE XIX. The regional ratios shall remain in effect for all votes taken during regional meetings for the duration of the Convention.

RATIONALE:

The addition of “and Elections” to the position Fraternity Constitution Chairman reflects the correct title for this position in the Fraternity. The term “Chairman” implies a male occupant of the position.

ARTICLE VII. CONVENTION

CURRENT LANGUAGE:

Section 5. Credentials Committee

There shall be a Credentials Committee appointed by Council no later than October 15, following Convention; the Treasurer shall be Chairman of the Committee.

PROPOSED LANGUAGE:

Section 5. Credentials Committee

There shall be a Credentials Committee appointed by Council no later than October 15, following Convention; the Treasurer shall be Chairman of the Committee.

RATIONALE:

The term “chairman” implies a male occupant of the position.

ARTICLE X. ELECTION, TERM AND VACANCIES

CURRENT LANGUAGE:

Section 1. Nominating Committee

A. A Nominating Committee of eight alumnae members, preferably with Council/Cabinet level experience, shall be elected at each Convention. Election of one representative each shall be in separate meetings of voting members of the eight geographic regions as defined by ARTICLE XIX Section 1. Members who have submitted an application to Executive Offices by two weeks prior to the Opening General Session of Convention are eligible for election. From these eight so elected, Council shall appoint the Chairman. A plurality vote shall elect.

PROPOSED LANGUAGE:

Section 1. Nominating Committee

A. A Nominating Committee of eight alumnae members, preferably with Council/Cabinet level experience, shall be elected at each Convention. Election of one representative each shall be in separate meetings of voting members of the eight geographic regions as defined by ARTICLE XIX Section 1. Members who have submitted an application to Executive Offices by two weeks prior to the Opening General Session of Convention are eligible for election. From these eight so elected, Council shall appoint the Chairman. A plurality vote shall elect.

RATIONALE:

The term “chairman” implies a male occupant of the position.

ARTICLE XVI. COLLEGIATE CHAPTERS

CURRENT LANGUAGE:

Section 1. Membership

Every undergraduate member of the Fraternity, matriculating at the institution where her chapter is located shall be a member of that chapter. At the discretion of Council, collegians may be granted exception under extreme circumstances and may assume alumnae status. Only those Delta Gammas who are students in the institution where a collegiate chapter is located may be members of that chapter. Graduate members registered in the institution where a chapter is located may be members of that chapter.

PROPOSED LANGUAGE:

Section 1. Membership

Every undergraduate member of the Fraternity, matriculating at the institution where her chapter is located shall be a member of that chapter. At the discretion of Council **or their designees**, collegians may be granted exception under extreme circumstances and may assume alumnae status. Only those Delta Gammas who are students in the institution where a collegiate chapter is located may be members of that chapter. Graduate members registered in the institution where a chapter is located may be members of that chapter.

RATIONALE:

Early Alumnae Status is a member status change that, under the parameters set by Council, is a paper transaction that does not require Council oversight. By allowing for member status changes to be approved by their designees, Council then has the authority to delegate this task to staff or volunteers for more efficient execution.

ARTICLE XXV. AMENDMENTS

CURRENT LANGUAGE:

Section 2. Required Notice

Notice in writing of any proposed amendments shall be sent by December 1 preceding Convention to the Fraternity Constitution and Elections Chairman who shall refer them to Council by February 1. By April 15 she shall submit the proposed amendments to the chapters, noting those approved by Council. Any proposed amendments to the amendments in the committee's report must be sent by June 1, preceding Convention, to the Fraternity Constitution and Elections Chairman. This provision shall not operate to prevent any amendment arising at Convention to these amendments sent as of June 1.

Section 3. Amendment by mail

The Articles of Incorporation and this Constitution may be amended between Conventions by mail, an electronic voting method, or any other method deemed acceptable by the Fraternity Constitution and Elections chairman and Council, by an affirmative vote of two thirds of the chapters, the members of Council, the Executive Director, the Regional officers, and those chairmen and/or directors as may be designated by Council; the vote value to be as provided in Article VIII. Section 3 and provided that the Fraternity Constitution and Elections Chairman shall have been given thirty (30) days prior to mailing. In order to be counted, votes must be received within six weeks of the date on which they were mailed by the Fraternity. Return is to be by ordinary US mail postage pre-paid to the Treasurer.

PROPOSED LANGUAGE:

Section 2. Required Notice

Notice in writing of any proposed amendments shall be sent by December 1 preceding Convention to the Fraternity Constitution and Elections Chairman who shall refer them to Council by February 1. By April 15 she shall submit the proposed amendments to the chapters, noting those approved by Council. Any proposed amendments to the amendments in the committee's report must be sent by June 1, preceding Convention, to the Fraternity Constitution and Elections Chairman. This provision shall not operate to prevent any amendment arising at Convention to these amendments sent as of June 1.

Section 3. Amendment by mail

The Articles of Incorporation and this Constitution may be amended between Conventions by mail, an electronic voting method, or any other method deemed acceptable by the Fraternity Constitution and Elections Chairman and Council, by an affirmative vote of two thirds of the chapters, the members of Council, the Executive Director, the Regional officers, and those chairmen and/or directors as may be designated by Council; the vote value to be as provided in Article VIII. Section 3 and provided that the Fraternity Constitution and Elections Chairman shall have been given thirty (30) days prior to mailing. In order to be counted, votes must be received within six weeks of the date on which they were mailed by the Fraternity. Return is to be by ordinary US mail postage pre-paid to the Treasurer.

RATIONALE:

The term "chairman" implies a male occupant of the position.

ARTICLE XXI. INSIGNIA

PROPOSED LANGUAGE:

To be added as Section 9 to Article XXI.

Section 9. Oath of Friendship

The Oath of Friendship, as written in 1889, shall be the official Oath taken by new members at the time of their Initiation. It will be the Oath of all initiated members.

RATIONALE:

The 1889 Oath of Friendship is one of the most important founding principles of Delta Gamma Fraternity, which states the values and commitment all initiated members have to our Fraternity.

This proposed amendment would be consistent with the other symbols of our Fraternity, as stated in Article XXI, which include our Badge, our New Member Pin, our Crest, our Flower, our Colors, our Seal and our Call. Adding our Oath of Friendship ensures that our commitment to Delta Gamma will not be compromised in word.

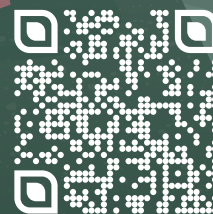

Proposed Foundation Constitutional Amendments

Article X Foundation Program Section 2 Committees

Current Language:

Section 2. Committees Committees, as may be necessary to assist the Board in carrying out the programs of the Foundation, shall be appointed by the Board of Trustees. The committees shall be appointed for a term of two years and be chaired by a Chairman, appointed by the Board of Trustees, who may serve only two such terms consecutively.

Proposed Language:

Section 2. Committees The Board of Trustees may appoint Committees as may be necessary in carrying out the programs of the Foundation.

Rationale:

The proposed language preserves the authority of the BOT to appoint committees but eliminates the term limit language. This provides the Board with flexibility to adjust the term limits for a particular committee and for committee service as needed.

The following proposed amendments change “chairman” to “chair” wherever that term appears in these Constitution provisions.” These proposed amendments will be presented at the Annual Meeting as a single motion.

Article III Membership Section 2 Classes of members

Current Language:

Section 2. Classes of members There shall be two classes of members, the Foundation Positions and the Fraternity Positions. The Foundation Positions shall consist of the elected members of the Delta Gamma Foundation Board of Trustees, the Delta Gamma Foundation Executive Director, and the Delta Gamma Foundation Directors and Coordinators. The Fraternity Positions shall consist of the Delta Gamma Fraternity Council and the Delta Gamma Fraternity Directors. The aggregate voting power of the membership shall be exercised by the Foundation Positions, collectively, and the Fraternity Positions, collectively, as follows:

- A. Fifty-one percent (51%) of the aggregate voting power of the membership shall be exercised collectively by the Foundation Positions; and
- B. Forty-nine percent (49%) of the aggregate voting power of the membership shall be exercised collectively by the Fraternity Positions.

Only individuals present at a meeting may vote. At each meeting, the fifty-one percent (51%) aggregate voting power of the Foundation Positions shall be allocated among the individuals serving in Foundation Positions. Similarly, the forty-nine (49%) aggregate voting power of the Fraternity Positions shall be allocated among the individuals serving in Fraternity Positions. The number of votes of each person in attendance serving in a Foundation Position and each person serving in a Fraternity Position shall be calculated prior to each meeting by the Chairman of the Foundation Board of Trustees, the Foundation Executive Director and the Foundation Constitution Chairman.

Proposed Language:

Article VIII Meetings Section 1 Schedule of meetings

Section 1. Schedule of meetings The Board of Trustees shall meet at least semi-annually, the time and place of the meeting to be decided by the Board. The Chairman or any two Trustees may call a special meeting. At least two weeks written or electronic transmission notice of a meeting must be given to each Trustee.

Proposed Language:

Section 1. Schedule of meetings The Board of Trustees shall meet at least semi-annually, the time and place of the meeting to be decided by the Board. The Chair or any two Trustees may call a special meeting. At least two weeks written or electronic transmission notice of a meeting must be given to each Trustee.

Rationale:

Article IX Executive Director

Current Language:

The Board of Trustees shall annually appoint an Executive Director of the Delta Gamma Foundation. The Executive Director shall be responsible for the proper execution of the functions, activities and programs of the Foundation within the provisions of the budget approved by the Board of Trustees. The Executive Director shall be responsible to the Board of Trustees and report directly to the Chairman of the Board.

Proposed Language:

The Board of Trustees shall annually appoint an Executive Director of the Delta Gamma Foundation. The Executive Director shall be responsible for the proper execution of the functions, activities and programs of the Foundation within the provisions of the budget approved by the Board of Trustees. The Executive Director shall be responsible to the Board of Trustees and report directly to the Chair of the Board.

Rationale:

The term “chairman” implies a male occupant of the position.

Article XIII Amendments Section 2 Required Notice

Current Language:

Section 2. Required notice Notice in writing of any proposed amendments shall be sent by December 1 to the Foundation Constitution Chairman who shall refer them to the Board of Trustees by February 1. By April 15 the Constitution Chairman shall submit the proposed amendments to the members, noting those approved by the Board of Trustees. Any proposed amendments to the amendments must be sent by June 1 preceding the annual meeting to the Constitution Chairman of the Foundation. This provision shall not operate to prevent any amendments arising at an annual meeting to these amendments sent as of June 1.

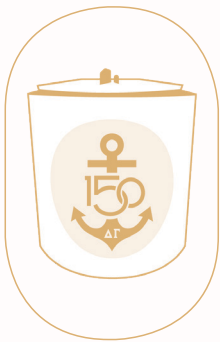
